You understand that if you do not show up to pick up your puppy as scheduled in the contract, you forfeit all funds paid as well as the puppy, which can then be offered to another buyer. _____ (initial and date)

I accept Walmart-to-Walmart or cash only for your payment, whether a NON-REFUNDABLE holding fee to hold the puppy of your choice or, if applicable, the balance of the full price of the puppy if you choose to pre-pay. You will be notified of the amount of required non-refundable holding fee when you are notified that your application has been accepted, but it is also posted on the website. This is based on the overall price of the puppy. The non-refundable holding fee is due within 24 hours of your notification of approval, along with my receipt of an emailed copy of your unchanged, signed, initialed, notarized Purchase Contract. The non-refundable holding fee will be applied to the purchase price with the remainder of the purchase price due **in full in cash at pickup (unless you prefer to pre-pay)**. If you change your mind, or you do not show to pick up the puppy at the agreed upon date/time, you forfeit the entire non-refundable holding fee, and the puppy will be made available to other buyers. _____ (initial/date)

If you decide at any time you do not want or can no longer keep or care for this puppy for any reason, ownership reverts back to me, the breeder, and you agree to return it to me, Karen Tharp, owner of Heirloom Boston Terriers (or my daughter Megan Tharp after I retire) at your expense. _____ (initial/date) You hereby agree that if this situation arises, you will deliver the puppy to me personally and **NOT ship or use a Puppy Nanny** in the best interest of the puppy. You agree to return puppy/dog along with ALL AKC registration paperwork you may have received – signed over to me - and any and all vet records as well as a written statement on why you are surrendering your puppy/dog. All puppy pack gifts (or their value in cash) will also be returned. I will also require you to sign a surrender contract. _____ (initial/date). I am committed to the dogs I breed and want to make sure they always have a safe, loving home to come back to. Bostons are born to be “forever dogs” and not to be passed around from owner to owner. It is very hard on them to lose their home and family. Puppy/dog is **never** to be re-homed to someone other than the breeder, who was the original owner. You will not be able to re-sell, give away or "loan out" this puppy and agree to this term. Puppy/Dog may not be re-homed, sold, put in a shelter or otherwise relocated upon penalty of \$5,000 liquidated damages. _____ (initial/date)

Applicant acknowledges if he/she is approved, (s)he will return an unchanged, signed, initialed and notarized original of the Purchase Contract within 1 week of receiving it. An email copy is due within 48 hours of buyer receiving it, and holding fee in full is due within 24 hours of notification of approval. Until all of these criteria are met, puppy is available to other individuals/families. _____ (initial/date)

If you are notified of your acceptance, a non-refundable partial reservation fee of \$500 is due within 24 hours. Once the puppies are born and priced, the balance of your non-refundable reservation fee is due within 24 hours or you will forfeit your partial non-refundable reservation fee. I will work with you to make sure you get matched with the puppy that best suits you, your lifestyle, and the desired characteristics you have communicated to me.
